## **“CANDIDATE’S AWARD” APPLICATION**

The Educational Trust Fund (ETF) of the Connecticut Society of Certified Public Accountants has established this annual award to assist candidates in satisfying the 150-hour requirement. The ETF will be providing awards of **\$3,000** each to selected scholarship recipients at the ETF Awards Dinner on Thursday, October 29, 2009. Attendance at the awards dinner is expected for scholarship recipients.

### **TO BE ELIGIBLE FOR THE CANDIDATE’S AWARD YOU MUST:**

1. Have completed a minimum of 120 hours from an accredited college or university; and
2. Have attained an overall grade point average of 3.0 (on a 4.0 scale)<sup>1</sup>; and
3. Be enrolled in an institution of higher learning in order to satisfy the 150-hour requirement of the Connecticut State Board of Accountancy; and
  - a. Currently be a resident of the state of Connecticut; or
  - b. Currently employed or have accepted an offer of employment at a firm, company, or agency located in CT.

<sup>1</sup>Applicants with overall GPAs of less than 3.0 may also be considered for this award at the discretion of the Trustees of the ETF.

**Please Note: Previous Candidate’s Award recipients are not eligible to apply.  
Applicants must meet the criteria stated above at the time of application deadline.**

### **APPLICATIONS MUST:**

1. Include an official copy of your college or university academic transcript.
2. Include a copy of Driver’s License (to satisfy eligibility requirement 3a above) or if not a CT resident proof of CT employment with a copy of your offer letter (to satisfy 3b above).
3. Be accompanied by one (1) original essay of approximately 500 words (typed) prepared by the applicant on the assigned topic.

**The topic for the 2009 Candidate’s Award is: THE FUTURE OF THE ACCOUNTING PROFESSION.**

Discuss what you consider to be the greatest opportunities and challenges facing the accounting profession. Please include a discussion of where you see yourself as an accounting professional in the future and your connection to those future opportunities and challenges.

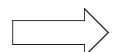
