DENTAL

Powerful member tools like **Ask a Hygienist** let members email their dental questions to a team of licensed dental professionals. **Dental Risk Assessment** helps members understand their oral health risk factors and **Dental Care Cost Estimator** helps members better understand the cost of their dental care.

Anthem Whole Health Connection® – Dental helps members with certain health conditions. Additional dental benefits are available without a deductible or waiting period. Eligible services are paid at 100% and won't reduce your coverage year annual maximum (if applicable).

Accidental Dental Injury Benefit provides members 100% coverage for accidental injuries to teeth up to the coverage year annual maximum (if applicable). No deductibles, member coinsurance, or waiting periods apply.

International Emergency Dental Program helps members traveling abroad to receive emergency dental care from licensed, English-speaking dentists. Eligible covered services will be paid 100% with no deductibles, member coinsurance, or waiting periods and won't reduce the member coverage year annual maximum (if applicable).

Special Offers discount program provides discounts on wellness products and services including a discount on ProClear Orthodontic Aligners – an alternative to expensive braces.

VISION

Savings of 20% off the balance on frames, 40% off extra pairs of glasses, and 15% to 20% off other non-covered materials like lens upgrades, additional supplies of conventional contact lenses, lens treatments, eyewear accessories, and more.

Anthem Whole Health Connection® – Vision refers members to ConditionCare programs to receive the extra support they need when a medical condition like diabetes is detected via a vision exam claim submission.

International Travel Solution – Should a vision emergency strike when traveling abroad, members can find a trusted eye doctor in 20 international destinations - offering quality care and authentic frames. They can get 24/7 phone support with translation services in 160 languages if they need help communicating with an eye doctor. Members can also request temporary emergency glasses that can be delivered within 24 hours in most locations. These services are at no cost to members, and they can even request reimbursement of any out-of-network benefits available to help cover the cost of eye care received.

Special Offers discount program provides discounts on wellness products and services including LASIK surgery.
