

Try it, You'll Like It!

n June 2012, we introduced a new look for the logo and branding of the Connecticut Society of CPAs, our first major change since the 1980s. Although we haven't conducted any formal research, anecdotally, I believe members have reacted quite favorably to the change. In fact, when we introduced the rebranding to the joint meeting of the Society's Advisory Council and Board of Directors two years ago, their reaction was unanimously in favor of what they saw.

As I noted in my May/June 2012 Connecticut CPA article announcing and explaining the rebranding, we made the switch from "CS" to "CT" in our fiveletter acronym to emphasize "Connecticut" rather than "Society" to underscore the inclusiveness of the word "Connecticut"; when we de facto advocate for CPAs, we do so for all Connecticut CPAs.

But "C-T-C-P-A" doesn't exactly roll off the tongue when you say each letter separately. And that's ok, because our intention with the rebranding remains that people would now say "the Connecticut CPAs" rather than "the C-T-C-P-A."

Realistically, "Connecticut CPAs" is how many, if not most, people outside of the profession refer to us. When I send an email to a member of Congress, for example, my subject line says "From Zampino Connecticut CPAs" - and my messages get read. The same applies to my messages to the state's mass media and other important audiences.

So try it - "I'm a member of the Connecticut CPAs." Sure, it's an acquired taste, but so are most of my favorite things I've come to savor over the years!



CPAs Urge Action to Stop State's Unsustainable Debt

Connecticut is on an unsustainable fiscal course. It's up to us to make the change now.

That's the message CTCPA Immediate Past President Camille Murphy, a partner at Bailey Murphy + Scarano in Branford, along with other CTCPA members and staff, have been delivering across the state as part of the CTCPA "Save Our State" campaign.

"Save Our State" is a nonpartisan, apolitical, educational effort sponsored by CTCPA to focus attention on Connecticut's current unsustainable fiscal and economic path, which threatens the future of residents' homes, jobs, families, and services.

In her presentation, "A Bipartisan Look at the Financial Condition of the State from Connecticut CPAs," Murphy told attendees at May's Connecticut 2014 Economic Update sponsored by the Connecticut Business and Industry Association (CBIA) that "This isn't about the blame game. We've all had a hand in it. We're in tough shape with a capital 'T.' We need to pay attention to what's going on."

The presentation garnered widespread media attention, including "Not adding up: CPAs say state debt is unsustainable" in the *Bristol Press* and the *New Britain Herald*. Murphy also appeared on WTIC-AM with Ray Dunaway on May 13, WDRC-AM with Brad Davis on May 14, FOX TV-61 on May 15 (evening and late newscasts), and WATR 1320-AM with Larry Rifkin on May 16.

"If we put all of our debt on the financial statements – everything we owe our pensioners and retirees – we're \$64 billion in debt," Murphy told Rifkin on WATR. "Of that \$64 billion, we owe \$46 billion to the people who used to work for us." Murphy bases those numbers on the financial statements and the notes to the financial statements that the state of Connecticut produces.

The rest of the debt is largely in bond payments. "If you're funding your operating deficit by borrowing money, it's the same as if you or I put our groceries on our credit card and we can't make the payments," Murphy said. "It's not healthy."

What Now?

"When you find yourself in a big hole, the first thing you should do is stop digging," Murphy told attendees at the CTCPA Essential Event in May.

Murphy and other CTCPA speakers recommend a five- or ten-year state budgeting plan, where lawmakers sit down with the true numbers on the table, both "on the books" and off, and evaluate the promises that have been made.

"There are going to have to be sacrifices, there's no question about it," Murphy said.

Adding to the stress is the fact that Connecticut ranks last or close to last on several key economic factors; businesses and individuals are leaving the state in favor of areas where taxes and economic conditions are more favorable. (Visit www.statedatalab.org to compare Connecticut to other states using various indicators.)

Murphy urges CTCPA members interested in spreading the word about the state's dire financial situation to volunteer for the "Save Our State" speakers bureau. Public speaking training sessions and materials, including the prepared "Save Our State" PowerPoint presentation and related handouts, will be provided to all speakers to help make the preparation process as simple as possible.

Members who feel comfortable speaking to local and statewide media can also volunteer to be a "Save Our State" media source. When calls come in from reporters, editors, or producers, CTCPA Public Affairs Director **Mark Zampino** will match them with members based on geographic location, expertise, subject matter, and other factors.



After Five Decades as Public Accountant, Thorpe Receives CPA Certificate

Jack Thorpe became a licensed Public Accountant (PA) in 1961 and spent more than five decades practicing on his own in three separate firms in Seymour and Woodbridge. Along the way, he earned a number of credentials, becoming an enrolled agent, an insurance broker, a securities broker, and more.

"I was actually the first public accountant chosen to be on the State Board of Accountancy, but I declined," Thorpe remembered. "I was too busy!"

In 2000, Thorpe watched his membership association, the Connecticut Association of Public Accountants, disband and give up its charter due to dwindling numbers. A few years later, an old PA friend informed him that he'd become a CPA.

"How'd you do that?" Thorpe asked. As it turned out, a law passed in 2006 allows licensed public accountants to convert their licenses to certified public accountant licenses without requiring any testing. Since PAs were also required to complete 40 hours of CPE a year, it was just a matter of Thorpe submitting his education hours and filling out an application.

Thorpe wasn't sure he'd attend the ceremony, joking that at 82 years old, he was "probably the oldest person in history to receive a certificate."

"But I put a lot of years into this profession, and it's an honor to receive my certificate," he said. "I'm proud of it."

Furthest Distance Traveled to Receive a Certificate: 1,700 Miles

Marisa Doras began studying for the CPA Exam in Connecticut, so she continued on her path to certification according to Connecticut's statutes, even after she moved.

When Doras received her certificate from Deputy Secretary James Spallone, she was a long way from home: nearly 1,700 miles, in fact, from her home in St. Thomas, U.S. Virgin Islands.

A whirlwind two-week U.S. vacation took her from Disney World to New York to visit friends and family and finally culminated in a stop at the Aqua Turf Club to receive her certificate.

Following the certificate ceremony, Doras spent some time with Connecticut friends before flying back to St. Thomas, where she currently serves as director of business and fiscal affairs for the Department of Education. Next stop: local certification in the Virgin Islands!


